Dear Ms President Gojkovic,

On 18 March 2018, members of the National Assembly of the Republic of Serbia Dušan Bajatović, Veroljub Arsić, Dubravko Bojić, Milovan Drecun, Vladimir Đukanović, Vesna Ivković, Ognjen Pantović, Aleksandar Šešelj and Danijela Stojadinović took part in the presidential elections in the Russian Federation as international election observers. Furthermore, Marija Janjušević and Slaviša Ristić accompanied the presidential elections in Crimea, occupied by Russia in contravention of international law, and thus gave legitimacy to an electoral process which it does not enjoy under international law.

The eleven deputies were presented in the Russian media as members of the Serbian Parliament and gave a mostly positive public assessment of the election, in part while voting was still occurring on Election Day. Their findings contradict the conclusions of the international election observation mission of the ODIHR-OSCE and the independent citizen observers' organization Movement "Golos".

The Code of Conduct for International Election Observers states that international election observation missions must be of sufficient size to "determine independently and impartially the character of election processes in a country and must be of sufficient duration to determine the character of all of the critical elements of the election process in the pre-election, election-day and post-election periods."¹ The assessments presented by the above mentioned members of the National Assembly stands in sharp contrast to these rules.

Moreover, by deliberately contradicting the findings of the ODIHR-OSCE long-term election observation mission, Mr Bajatović, Mr Arsić, Mr Bojić, Mr Drecun, Mr Đukanović, Ms Ivković, Mr Pantović, Mr Šešelj, Ms Stojadinović, Ms Janjušević and Ms Ristić aimed to misinform the Russian public about the real international perception of the electoral process. This can be seen as an attempt to damage the reputation both of ODIHR/OSCE and the Serbian National Assembly.

The European Platform for Democratic Elections (EPDE) is a civil society initiative of fourteen European election observation organizations with a secretariat in Berlin. Before EPDE was declared an "undesirable organization" by the Prosecutor General's Office of the Russian

Federation on 13 March 2018, the Russian election observation organization “Golos” was a member of EPDE.

The EPDE Secretariat asks you to clarify:

Did the MPs Bajatović, Arsić, Bojić, Drecun, Đukanović, Ivković, Pantović, Šešelj, Stojadinović, Janjušević and Ristić inform the National Assembly about their intention to observe the Presidential Elections in Russia, and what was the response to this from the National Assembly?


Did the mentioned MPs inform the National Assembly on who organised and financed their observation mission in Russia?

Does the National Assembly intend to investigate the behaviour of the mentioned MPs and inquire whether they breached the Code of Conduct of the National Assembly?

EPDE has pointed out the misuse of the instrument of international election observation during a high-level conference organized in March 2017 in the European Parliament, and has developed a series of recommendations that you can find in the attached brochure. Here you will also find details on the international observer missions that the Federation Council and the State Duma of the Russian Federation invited to the presidential elections in March 2018 in the Russian Federation.
